
- (e) **TRUSTEES** means the Original Trustees and/or the Nominated Trustees for the time being.

5. The income and property of the Trust will be applied solely for the promotion of the objects of the Trust, as set forth herein before and also any other thing related to Education and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonuses or otherwise howsoever by way of profit to any person provided that nothing herein contained shall prevent payment in good faith of remuneration of any Officers or servants or employees of the Trust of other persons in return for any services rendered to the Trust.
6. The Trust shall not participate in or intervene in any political campaign.
7. (a) True accounts shall be kept of all sums of money received and spent by the Trust and the matters in respect of which such receipts and expenditure take place and of property, credits and liabilities of the Trust. The accounts of Trust shall be maintained regularly.
- (b) To operate the Bank A/Cs, the Trustee Board must select at least **TWO** authorised signatories including the Chairman, and the Secretary or the Assistant/Additional/Joint Secretary or the Treasurer or any Trustee Member.
8. (a) The Trust and the management thereof shall vest in the Board of Trustee and there shall be not less than 4 (four) not more than 15 (fifteen) Trustees of the Trust. The parties hereto have been nominated and appointed Trustees shall appoint a Secretary, an Assistant/Additional/Joint Secretary and a Treasurer and be entitled to terminate his/her employment. A Trustee may retire at any time by giving one month's notice in writing to the other Trustees of his/her desire to retire. The office of a Trustee shall be vacated if he shall become of unsound mind or shall be charges with an offence involving moral turpitude or absent himself from three consecutive meetings of the Board of Trustees without leave of absence from the Board.

6. To make such rules regulation from time to time for the management and conduct of the affairs of the Trust and its properties and assets.

#### 11. THE TRUSTEES WILL ALSO HAVE THE FOLLOWING POWERS:
